ORDER

In pursuance of the Directorate of Food Civil Supplies, & Consumer Affairs, Assam, Guwahati's W. T. Message No. DS. 197/2011/39 dated 17/11/2011 the allocation of total 5860.00 quintals of **Additional APL rice** allotted for the months of **December/2011, January/12 and February/12** @ 5860.00 quintals per month, under P.D.S for Kamrup Sadar Sub-Division of Kamrup District and M/S Baghmara Char GPSS Limited under Barpeta District, are hereby made to the nominees as detailed below for public distribution. The nominees are directed **to deposit the Government fixed value of allotted Addl. APL Rice to the F.C.I., Guwahati @ Rs. 830.00 per Quintals within 15/12/11 for the month of December'11, 15/01/12 for the month January/12 and 15/2/12 for the month of February/12 to arrange lifting of rice therefrom within ,20/12/11, 20/01/12 and 20/2/12 respectively** without fail. They are also directed to submit the arrival report against lifting of Additional APL rice so allotted and issue the same to the appointed retailers (i. e Agents/FPS dealers) attached with them for ultimate distribution amongst Family Identity Card holders **excluding MMASY'10 families** under P.D.S. at a quantum of **13 kgs 220 grams per family** per month, at the rate fixed by the undersigned Licensing Authority.
