**O R D E R**

In pursuance of the Director of Food Civil Supplies & Consumer Affairs Assam, Guwahati's order issued under Memo No. DS-158/2011/83 dated 25-11-2011 regarding allotment of **whole-meal atta** and bran to be produced by the Roller Flour Mills out of **APL wheat** allotted for **November/2011** read with the guideline in this connections issued by this office vide Memo No.KSL.137/2005/12 dated 20-1-2006, I Shri S. K. Roy, ACS, Deputy Commissioner Kamrup Amingaon, in exercise of the powers conferred by clause-26 read with clause 28(b) of the Assam Public Distribution of Articles Order,1982, do hereby make the sub-allocation of aforementioned whole meal atta to the undermentioned sub whole saler G.P.S.S. /WCCS Limited of Kamrup Sadar Sub-Division as per quantity shown against their names with the direction to lift the wholemeal atta from the respective Roller Flour Mills **within 20-01-2012** on payment of ex-mill price @ **737.90/- per quintal** in respect of Wholemeal atta fixed by the Govt. for the purpose of distribution of same through Public Distribution System a quantam of 1.156 kilogram per family FIC as shown against their names.

It is further ordered that, the allottee G.P.S.S. Limited/W.C.C.S Limited shall deposit the ex-mill price of wholemeal atta only in the shape of Bank Draft/Banker's Cheque payable in favour of name and style of Roller Flour Mills concerned to them and also to obtain necessary endorsement of quantity of whole meal Atta to be lifted (wholly or partly) according to allotment, in the 'Permit Book' from Food, Civil Supplies and Consumer Affairs Branch, Kamrup. The Roller Flour Mills in turn shall release wholemeal atta (FAQ) forthwith and also make necessary records in the 'Permit Book' of the allottee GPSS/WCCS Limited showing the cash memo number with date and quantity issued etc. The R.F. Mills shall keep the left out stock of wheat bran as shown below as reserved stock for flood relief.

7. The Secretaries of all GPSS/Wholesale CCS Limited. Under Kamrup Sadar Sub-Division. They are directed to lift the allotted quantities of wholemeal atta **within 20.01.2012 without fail** and to issue the same to the consumers through F. P. Shop holders/Agents.
8. The District Informatics Officer, NIC, Kamrup for information. He is requested to publish this allotment order in the District *website* as per Government Standing instructions.
