ORDER

In pursuance of the Directorate of Food, Civil supplies & Consumer Affairs Assam, Guwahati's W.T. Message Nos. DS. 114/2010/PT-1/402 dtd. 20/09/2012 and Deputy Commissioner, Kamrup, Amingaon's Order No. KSL-201/2010/109 dtd. 27/09/2012 the sub-allocation of Additional BPL rice has been made to GPSS/ WCCS for distribution among the special FIC holders under Mukhya Mantrir Anna Surakhya Yojona/2010 as follows for the month of **October' 2012**.

The pricing structures of rice (MMASY) are (1) The nominees ( i.e. GPSS/WCCS) are to pay Rs. 565/- per Qtl. (2) End consumer price at BPL rate per KG.

All Secretaries of the GPSSs / WCCS will lift the allotted rice under MMASY/2010 from FCI, Guwahati within 30/10/2012 depositing the value @ Rs. 565/- per Qtl. on or before 25/10/2012 without fail taking forwarding letter from the Authority.
