Norms & Functions:

- 1 The Committee will follow the guideline while selecting beneficiaries
- 2. The beneficiaries shall be selected from the BPL category/ erosion affected families with preference to women.
- 3. In case of agricultural items; preference will be given to Field Management Committee (FMC)/ Agirculture Service Group(ASG) duly registered under Agriculture Deptt & Self Help Group(SHG) duly registered under P&RD Deptt. from within the areas under the Char Areas Dev project & Development Blocks covering the Char Areas of the district.
- 4. Selection of Individual beneficiaries will be as per Sl. No. 2 above.
- 5. A group or individual beneficiary receiving benefit under similar scheme from other department will not be eligible for consideration.

6. The Char Development Project Officer (CDPO), Member Secretary shall call for applications by wide publicity through proper advertisements in news papers& subsequently the applications will be scrutinized by the BDOs concerned & CDPO. The CDPO will submit the list of valid applications to the Deputy Commissioner for selection of beneficiaries by the DLSC.

7. The Director, Char Areas, Assam will ensure wide publicity of the scheme through news papers advertisements & other means. Copies of the same will be marked to DC, Zilla

Parishad Office, Revenue Circle Office, Blocks & the office of the CDPOs.

8. The Deputy Commissioner will review the benefits accrued from the inputs distributed on a monthly basis in the DDC meeting.

9. The CDPO shall submit Monthly Progress Report (MPR) & Actual Payee Receipt (APR) to the Director, Char Areas Development, Assam. The Director, Char Areas will accordingly apprise the Govt.
