In pursuance of the Director, of Food Civil Supplies & Consumer Affairs Assam Guwahati's W.T. Messages DS. 132/2012/69 dated 19.10.2012 and DS. 132/2012/79 dated 17.05.2013 regarding sub-allocation of subsidized wheat bran to eligible milk producers, co-operatives societies out of the wheat bran produced by the 5(five) nos of Roller Flour Mills located at Amingaon area out of APL/ Addl APL wheat, I Dr. J. Balaji, IAS Deputy Commissioner Kamrup, Amingaon in exercise of the power conferred by clause 26 read with clause 28(B) of the Assam public distribution of Articles Order, 1982 do hereby make the sub-allocation of **1307.48 qtls** of **w/bran** amongst the below named GPSS under the Kamrup Sadar Sub-Division from the accumulated stock held by the aforesaid Roller Flour Mill for ultimate distribution to the milk producers under 21 (twenty one) nos of **Diary Co-operative Societies (DCS)** and **Milk Producer's Institution (MPI) registered** under the town milk supply scheme Khanapara, Guwahati-22 as per lists enclosed herewith shown against each GPSS at Govt fixed price of Rs. 600/- per qtl (Ex . mill price).

The Sub allocation is meant for Jan/Feb/March/14

Validity of lifting by the **GPSS** from the **R.F. Mills** will be up to **...10.03.2014.**

Validity of lifting by the **DCS & MPI** from **GPSS** will be up to **...20.03.2014.**

Each GPSS, DCS and MPI would furnish returns/ utilization of the wheat bran so sub-allocated for subsequent sub-allocation.
