

ORDER

In pursuance of the Directorate of Food, Civil Supplies, & Consumer Affairs, Assam, Guwahati's W. T. Message No. DS 108/2013/15 dated 26/06/2013, the allocation of total 1480.00 quintals of Additional APL rice allotted for the months of April, May, & June/2013, under the Government fixed value of allocation for Kamrup Sadar Sub-Division of Kamrup District and M/S Baghmara Char GPSS Limited to the nominees as detailed below for public distribution. The nominees are directed to deposit the month of April, May, June/2013 Addl. APL Rice to the F.C.I., Guwahati @ Rs. 830.00 per Quintals within 05/07/13 for to arrange lifting of rice therefrom within 10/07/13, respectively without fail. They are also directed to submit the report against lifting of Additional APL rice so allotted and issue the same to the appointed retailers (i.e. Agents/FPS dealers) attached with them for ultimate distribution amongst Family Identity Card holders excluding MMASY'10 families under P.D.S. till 20.07.2013 at the rate fixed by the undersigned Licensing Authority. The quantum of distribution will be 3.300 kg per family instead of 3.354 Kgs per family as per calculation as it is not possible to monitor the fractional quantity (i.e. 54 grms) and hence it is decided to lapse 29.40 qtls.
