ORDER

In pursuance of the Directorate of Food, Civil Supplies and Consumer Affairs, Assam, Guwahati's W. T. Message No. DS. 22/2012/57-A dated 07/06/2012, allocation of **6530.00** quintals, and **250.00** quintals of Levy Sugar **under P.D.S quota for the month of June/12** in respect of **Kamrup Sadar Sub-Division of Kamrup District and M/S Baghmara Char GPSS Limited under Barpeta District** respectively, are hereby re-allocated to the P.D.S. nominees as detailed below for public distribution. The nominees are directed to deposit the Government fixed value of allotted Levy Sugar to the F.C.I., Guwahati and arrange lifting of the same there from **within 30-06-2012** without fail. They are also directed to submit the arrival report against lifting of Levy Sugar so allotted and issue the same to the appointed retailers (i.e Agents/FPS dealers) attached with them for ultimate distribution amongst Family Identity Card holders under P.D.S. at a quantum @ **0.648 Grams per head** per month at Government fixed rate.
